The collection consists of letters written by Hiram Warner Camp, Company A, 7th Georgia Infantry, and Walker G. Camp, Company A, 7th Georgia Infantry, to their sister, Miss Lizzie Camp, Newnan, Coweta County, Georgia; correspondence between Lizzie Camp Reynolds and her husband, William M. Reynolds; and several folders containing newspaper clippings, obituaries, programs, pamphlets, photographs and published works, all of which reflect the social, political, economic and religious life of Newnan, Coweta County, Georgia, in the late 19th and early 20th Centuries.

The Vicksburg Campaign and Harper's Ferry, Virginia, are discussed in two of the letters.
